About The Loretto Hospital

In the fall of 2018, The Loretto Hospital embarked on a comprehensive Community Health Needs Assessment (CHNA) process to identify and address the key health issues for our community.

Founded in 1939 by a group of community doctors who wanted to create a patient-centered hospital that would serve the community regardless of a patient's ability to pay, Loretto has provided comprehensive medical care and social support services to the Austin Community for nearly 80 years.

Austin represents one of Chicago's most chronically underserved populations. Ninety percent of the population of the 117,527 residents is African American and more than two-thirds of the population is two times below the poverty level. Additionally, the Chicago Department of Public Health – Chicago Health and Health Systems Project (April 2006) indicates that the other risk factors affecting the community include no access to healthcare, smoking, obesity due to poor nutrition and lack of exercise, and poor education. Over 70% of our patients are on Medicaid and reflect the overall demographic and socioeconomic characteristics of the community.

Each year The Loretto Hospital receives over 30,000 patient visits and on average has about 5,000 inpatient admissions. The major focus of the hospital has been on inpatient and emergency care. The emergency department has been the front door to the community for both emergent and non-emergent care because residents do not focus on prevention and are forced into ER utilization for their episode of illness. The emergency department not only provides enhanced emergency services but also serves as the gateway for our patients to obtain primary care services through the hospital's ambulatory care clinic. Additionally, it's an opportunity for Loretto to start engaging patients into a more preventive healthcare lifestyle through our ancillary and specialty clinic services. For over 45 years, The Loretto Hospital has also provided a broad range of inpatient and outpatient mental illness, and substance use disorder treatment and supportive recovery services through The Addiction Center.

The Addiction Center is a comprehensive Alcohol and Substance Use Disorder facility providing a full continuum of care, using Level of Care placement criteria authorized by the American Society of Addiction Medicine (ASAM). The Center currently has twenty-eight (28) Medical Stabilization beds and sixteen (16) beds for our residential population. Additionally, it is in the process of adding thirteen (13) beds for medical detoxification. The center is operational twenty-four (24) hours, seven (7) days a week, with appropriate coverage by the Medical Director. The facility also provides outpatient services including intensive outpatient (IOP) and DUI services. The center is licensed by the Department of Human Services, Division of Substance Use Prevention and Recovery (SUPR). The following primary treatment services are available to all center patients:

- Comprehensive Case Management
- Medical/Medication Monitoring
- Individual Counseling
- Group Counseling
- Peer Support

- Psychiatric Evaluation and/or Medication Management
- Educational Seminars
- Introduction to and Participation 12-Step Support Group
- Comprehensive Family Education
- Recreational Re-socialization Activities
- Nutritional Assessments
- Stress Management Training

The Loretto Hospital Addiction Center's mission to provide accessible, relevant and comprehensive substance use disorder services to the residents of our communities, in an atmosphere that promotes dignity, self-empowerment and holistic human and community health, and to serve as a model, educator and leader to our community in its battle against substance misuse.

It is our vision to create a substance use disorder treatment network that provides each of our patients with access to specific substance use disorder, psychiatric, medical, and social services as well as other resources that he or she requires to achieve and maintain a healthy lifestyle.

The Addiction Center's seeks to provide the highest quality of care in the treatment of the chemically dependent patient within the least restrictive setting. Every patient is treated in an atmosphere that instills dignity, self-esteem and the emergence of hope. The Addiction Center provides a full continuum of substance use disorder services, which serves as the basis for each patient's symptom-specific plan of care. Its organizational structure is based upon a system of quality, accountability and efficient provision of service delivered to every patient.

Our overall goal at The Loretto Hospital is to increase the life expectancy of those in the community by 20 years by consistently providing excellent patient care and preventive health education in a safe holistic environment by: improving quality and patient satisfaction; increasing access to care, physician alignment; and, meeting the medical needs of the communities we serve.


Definition of the Community Served

Loretto Hospital's community, as defined for the purposes of the Community Health Needs Assessment,

included each of the residential ZIP Codes that comprise the hospital's Primary Service Area (PSA), including: 60707, 60639, 60651, 60644, 60624 and 60623 and Secondary Service Area (SSA), including: 60164, 60160, 60104,60153, 60155, 60130, 60304, 60302. A geographic description is illustrated in the following map.

This community definition was determined because greater than 80% of Loretto Hospital's patients originate from this area.



Demographics of the Community

The Loretto Hospital's geographic catchment area is Austin and the immediate surrounding communities' areas of West Garfield Park and North Lawndale, and consist of zip codes: 60644, 60651, 60639, 60624, and 60707. The Austin community is the largest community area in the city of Chicago by land area; and, the second largest by population. According to the 2016 American Community Survey, the total population for the Austin community is 97,611. Twenty- four (24.1%) of the community is living below the poverty level and represents a portion of the 52.3% of the" medically needy" in Chicago, which are located on the west side.
